Description of necessary first aid measures

Section 5. Fire-fighting measures

Extinguishing media

Precautions for safe handling

Use a suitable hand truck for cylinder movement.

Conditions for safe storage, including any incompatibilities : Store in accordance with local regulations. Store in a segregated and approved area. Store away from direct sunlight in a dry, cool and well-ventilated area, away from incompatible materials (see Section 10). Cylinders should be stored upright, with valve protection cap in place, and firmly secured to prevent falling or being knocked over. Cylinder temperatures should not exceed 52 °C (125 °F). Appropriate engineering controls : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
